

**Terms & Conditions for the Election for various offices and members of the Executive Committee of the Central Secretariat Club to be held on 24<sup>th</sup> April 2026 (Friday) at Club Premises.**


1. The Executive Committee shall consist of President (one), Sr. Vice President (one), Jr. Vice President (one), General Secretary (one), Joint Secretary. (one), Sports Secretary (one), Treasurer (one), Entertainment Secy. (one), Members 2% of the total Membership subject to a maximum of ten, three members nominated by the Government of India in the DOPT.
2. The nomination form for contesting election for the executive committee may be obtained from the office of the club. The eligible members who are in Govt. Service contesting for functional posts and the Executive Committee shall submit NOC from their respective office on or before filing nomination i.e. 07.05.2026
3. The copy of sample nomination form and the final list of the eligible members as on the said date has been displayed/affixed on the notice board. These may however be obtained by the members contesting election from the office on any working day before commencement of the election.
4. The Executive Committee shall be elected from amongst the members eligible for election for a period of one year.
5. The nominations for the posts of President, Senior Vice President and Junior Vice President shall be invited from retired Central Govt. employees.
6. The functional posts e.g. General Secretary, Joint Secretary, Treasurer, Sports Secretary and Entertainment Secretary, shall be held by working Central Govt. employees.
7. Nominations for election as member of the Executive Committee shall be invited from three working Central Govt. employees. Out of the three working Central Govt. employee one shall be a woman, in the event, no woman candidate files nomination, vacancy so caused, shall be filled in by a male candidate.
8. Nominations for election as member of the Executive Committee shall be invited from seven Retired/Pensioners of Central govt.
9. The Executive Committee, therefore, in effect shall have eleven working Central Govt. employees. (Including three nominated by DOPT) and ten retired/ pensioners of Central Govt.
10. No working Central Govt, employee shall be eligible to contest elections either for the functionary posts or membership of the Executive Committee unless he/she is left with not less than one year of service on the last date fixed for filing the nomination,
11. The members of the club, who are not the Central govt. working employee or Central govt retired/superannuated pensioner will not be eligible for contest/holding any position either as members of the Executive Committee or any of the Office bearer's posts However. They will cast their vote.
12. A member eligible to contest elections shall not be entitled to file nomination papers and contest elections for more than one post of office bearer and the membership of The Executive Committee simultaneously. In the event of election to both the office and Memberships he/she shall have to opt to for either of the two in writing within 24

- hours of the declaration of the result of the election.
13. Members in arrears with regard to subscription and other dues of the Club on the date the nomination papers are filed shall not be eligible to propose, second and contest in the elections.
  14. A member who is in arrears with regard to club subscription and other dues shall not be eligible to vote in the elections.
  15. No Member shall be eligible for holding a particular office for more than two consecutive terms.
  16. Member, who is serving Government employee, shall be eligible for holding elective office(s) for period of 2 terms or for a period of 5 years whichever is earlier for which prior sanction would be required when a Government servant contests an election. (Refer OM No. 11013/1/2016-Estt.A-III dated 27.02.2020 issued by DoPT. GoI)
  17. To be elected as officer bearers or members of the Executive Committee, a member must have completed at least a period of 12 months on the last date of filing the nomination papers. However, he/she can cast his/her vote in the elections.
  18. Every member shall have a right of a single non-transferable vote.
  19. Returning Officer/Asst, Returning Officer and Polling. Officer be appointed from amongst the members and they are not eligible for contesting the election but they Can vote in the election.
  20. Govt Officers from the DoPT will be appointed as Observer(s) in view of fair and transparent elections of the Executive Committee.
  21. Authenticate list of eligible members for voting duly signed & stamped by the General Secretary should be provided to the RO/ARO.
  22. No sticking of election pamphlets would be allowed anywhere in the club premises or its walls interior or exterior.
  23. No Guests and outsiders will be allowed in the club on previous day of the election, in view of preparation of elections.
  24. Only members will be allowed on the day of Elections i.e. 31.05.2026. No spouse or & children will be permitted on that Particular day.
  25. Absolute no drinking would be permitted on the day of election in the Club's premises. The police personnel on duty would be briefed to take prompt necessary action.
  26. The bar in the club will be closed on the day of election.
  27. The elections shall be held by secret ballot and shall be conducted under the general supervision and guidance of the Returning Officer.
  28. To avoid proxy voting identification of every member at the time of polling would be done by polling officer. Verification would be primarily by club's identity card, however, in the absence of this card, original photo I card in the form of Voter Id, office Id, PAN Card, Driving License, Aadhar Card would also be accepted.
  29. The voting will commence from 11:00AM to 3:00 PM on 31.05.2026 in the club Premises. The voter who would have already entered the Polling Booth shall however be allowed to cast their votes,
  30. The Ballot boxes duly sealed would be kept in the designated Election office in the

- Club. Precaution for the safe custody would be ensured by the Returning Officer(s) in the presence of the candidates or their agents, if any.
31. The votes so cast shall be counted under the supervision of the Returning Officer and in the presence of the Observer and candidates or their agents, if any. The counting of the vote shall commence after concluding the voting on the 31.05.2026 itself and the Returning Officer shall announce the results of the elections on the basis of the majority of the votes secured by the various candidates, on the same day, but in any case, not later than on the following day.
  32. There would be no late-night counting after 12'o midnight. The counting would thus be done next day and the result would be declared soon after.
  33. The appeals, if any against the decision of the Returning Officer may be made in writing to the President/Senior Vice President whose decision on such appeals shall be final.
